2017 MISDEMEANOR BAIL SCHEDULE

PENAL CODE

Penal Code §1270.1 prohibits the release of an arrestee on OR or bail in an amount other than that set forth on the bail schedule prior to a hearing in open court for (1) a violation of §243(e)(1) P.C., (2) a violation of §273.6 P.C. if the arrestee made threats to kill or harm, has engaged in violence against, or has gone to the residence or workplace of, the protected party.
